3. The Exhibitor is responsible for the security of their goods against all perils, at all times, including set-up, exhibition hours, and take-down of their display.
4. The Exhibitor agrees to staff their display at all times during the event. 7:30 am – 2:00 pm.
5. Exhibitor display set-up time is May 28, 12pm-5pm or May 29, 6:00 am – 7:30 am.
6. Exhibitor display take-down is after 2:30 pm on May 29, 2019.
7. The Exhibitor is responsible for removing all goods and materials from the exhibitor floor after the event, and leaving the space rented in a clean and orderly state.
8. The Participating Utilities agree to promote the event in their service territories.
9. The Power Factory Ltd shall not be liable in any way for any damages or consequential injury of any nature whatsoever sustained by the EXHIBITOR or any employee, invitee, agent, or customer or any other person who may be on the registered space at the Grand Olympia , or for loss or damage or injury

to any property belonging to the EXHIBITOR or employee, invitee or agent of the EXHIBITOR or to any other person whose property is on the registered space or in the Grand Olympia.

The EXHIBITOR hereby agrees to, and, shall indemnify and hold harmless The Power Factory Ltd. from and against any and all claims, including without limitation, claims for personal injury or loss or damage to property arising from or out of any matter whatsoever which occurs as a result of the EXHIBITOR's action or inaction in connection with the operations of the Expo. This indemnity includes compensation for costs, counsel fees, expenses, and liabilities incurred through any such claim.

The EXHIBITOR shall at all times have in force a multi-peril and public liability insurance policy in a minimum amount of two million dollars (\$2,000,000.00) covering public liability, bodily injury, food products liability and property damage. The Power Factory Ltd shall be named as an additional insured on such policy and a certificate of insurance in conformity herewith shall be delivered to The Power Factory Ltd on or before the date of the Expo.
